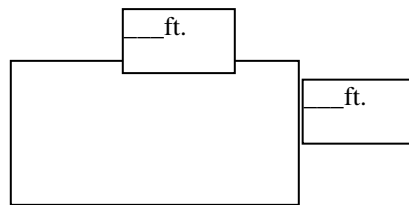

Should you require 220 Volt electrical service, there will be an additional charge of \$75.00 per hook-up. *Fees: \$425.00 per booth.* Corner spaces may carry additional costs. 50% deposit due with signed contract, if space is offered. Balance due prior to the Fair opening.

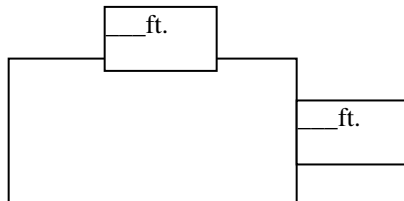

One-time \$75.00 hook-up fee additional for 220 service. *Fees: 10-30 amp service - \$68.00 per front foot; 35-70 amp service-\$75.00 per front foot; 75 amp service and above - \$85.00 per front foot. Additional space may be purchased for patron seating at a rate of \$55.00 per front foot, based on availability.* 50% deposit due with signed contract if space is offered. Balance due prior to the Fair opening.

_____ **Food Court Vendor** – permanent food booths in centrally-located court. A good option for vendors that do not have a food trailer. Each booth is 14' x 14', outfitted with 110V and 220V electrical outlets, three sinks, hot and cold running water, propane lines run from the outside of booth; ample shelving, screened, sliding service windows. Vendor must provide all appliances and other equipment as needed. Refundable deposit of \$200.00 due with contract. *Fees: \$1,000.00.* Balance due prior to the Fair opening.
